## **BACKGROUND INFORMATION:**

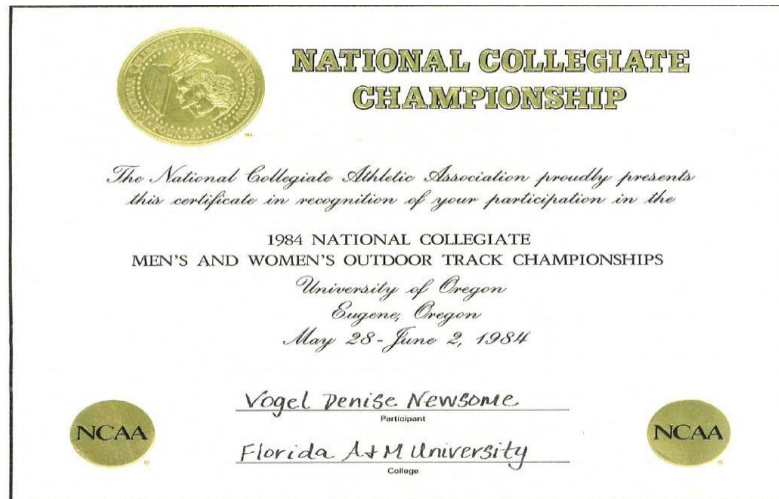
Here are a few FACTS that you may want to know about Community Activist Vogel Denise Newsome:
