White Supremacy and their "NEW World Order!" It
was said that Donald Trump's Presidency would
DIVIDE the USA! The DIVISION is here and
the Utica International Embassy has been FORMED!!

The DIVISION has come LAWFULLY and LEGALLY!!

a) As early as December 2008, I flew to Washington, DC. to meet with U.S. Senator Patrick Leahy and U.S. Congressman John Conyers to address the Racist/Terrorist, etc. acts of the USA's Federal and State Government Officials, Lawyers, etc. However, like CONARDS, Leahy and Conyers hid from me while Conyers sent one of his Lawyers out to talk to me. This trip resulted in RETALIATION and my being TERMINATED from employment with a JEWISH/Zionist Controlled Law Firm (Wood + Lamping) as well as other attacks!!

b) As early as July 2010, I took the time to NOTIFY of the COLLAPSE and/or FALL of the USA should its Government Officials, etc. continue on such a DESTRUCTIVE Course! To NO Avail!!! This notification was sent via Email and resulted in RETALIATION from U.S. President Barack Obama, his Legal Counsel Baker Donelson, and J.P. Morgan Chase Bank with the HELP of the Commonwealth of Kentucky SEIZING my Bank Accounts for "CHILD" Support with KNOWLEDGE that:

- a) I have NO Child(ren)
- b) I have NEVER Married
- c) I have NEVER Aborted Child(ren)
- d) I have NEVER Adopted Child(ren)

- c) As early as October 2010, the Supreme Court of the United States ("SCOTUS") was ~~NOT~~ NOTIFIED through Court document of the CRIMES being carried out by their Legal Counsel Baker Donelson and White ~~Supremacist~~ Supremacist/Ku Klux Klan connections!!
- d) As early as January 2011, I reached out (via Email) to U.S. Kentucky Senator Rand Paul to initiate INVESTIGATION(S) into U.S. President Barack Obama, his Legal Counsel Baker Donelson, etc.

- l) About 2015, held FIRST meeting at Town Hall in Utica, MS EXPOSING Baker Donelson and the Ku Klux Klan's, etc. PLANS for the Town of Utica, etc.
- m) About March 2016, held FIRST Television Interview with "REAL NEWS" with Dr. Eldridge Henderson sharing PLANS of a "NEW" Government!!

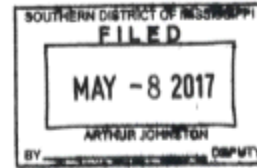

PRELIMINARY STATEMENT

1. The Sheriff's Department of Madison County, Mississippi ("MCSD") implements a **coordinated top-down program** of methodically targeting Black individuals for suspicionless searches and seizures while they are driving their cars, walking in their neighborhoods, or even just spending time in their own homes (the "Policing Program"). MCSD deputies frequently use unjustified and **excessive force** in conducting these searches and seizures.

2. The MCSD's Policing Program impacts virtually every aspect of Black residents' lives. Simple daily activities—such as commuting to work, grocery shopping, visiting friends and family, attending church, or even sitting on the steps outside one's own home—present the

Every attempt will be made to resolve hostage situations without injury or a loss of life; however, force will be used, when necessary, to rescue the hostages and apprehend the abductor(s).

HEALTH INFORMATION

MEDICAL/DENTAL:

Health Appraisals will normally be performed by the medical personnel within 14 days of incarceration. You are not allowed to have medication in your possession, without written permission from the Nurse therefore, you will receive prescription medication at regular "Med Rounds" Inmates shall not be forced to take any medication. However, any inmate who may become violent or experience medical difficulties without medication will be isolated and monitored until instructed otherwise by the Medical Staff.

Where I was IMMEDIATELY INJECTED with drugs/ medication that their Officials applied through the use of DEADLY FORCE and holding me down although they were INFORMED of pending ~~leg~~ Legal matters with the United States Department of Justice as well as my VERBAL objections and refusal of their drugs/medications!!

I was told my Kidnappers would be holding me for 55 days as they attempted to EXTORT approximately \$3,000 in Ransom for me to obtain my FREEDOM alleging monies sought being for unpaid Tickets for

- e) Resisting Arrest

As noted in RESPONSE to frivolous Charges, NO Formal Charges were ever filed and Charges are NOT Felony charges!!

Any Order (Court) was timely requested; however, REFUSED and never issued on me. This matter can be viewed on our Website under "USA Situation" as well as in my Slideshare Forum.

The March 25, 2019, Kidnapping and False Imprisonment, etc. was also done to UNDERMINE and OBSTRUCT a Federal Investigation by the United States Department of Justice ("USDOJ")!! My DEATH and/or MURDER is sought in efforts to CEASE such Investigations into the Formal Charges sought.
