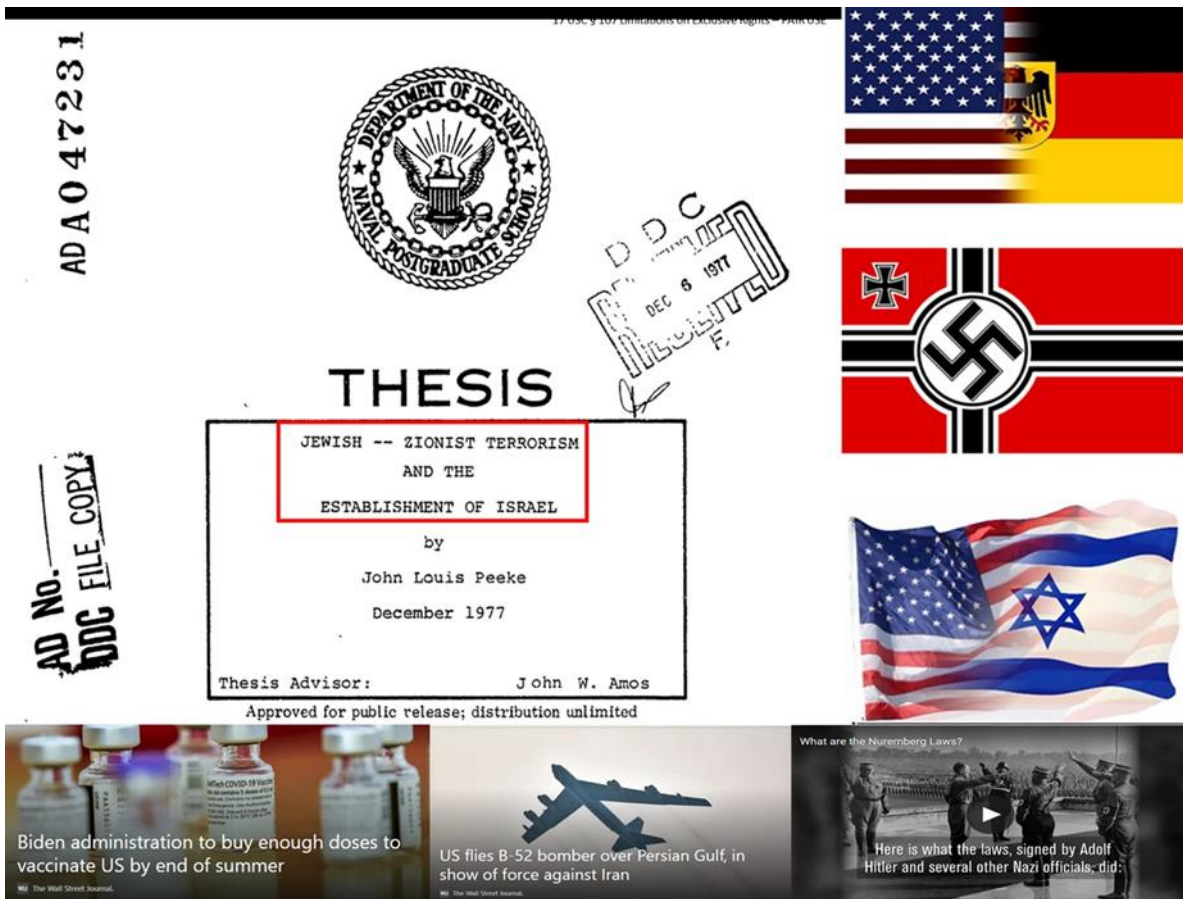

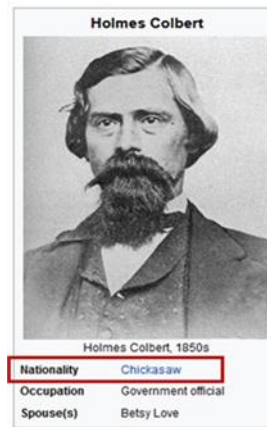
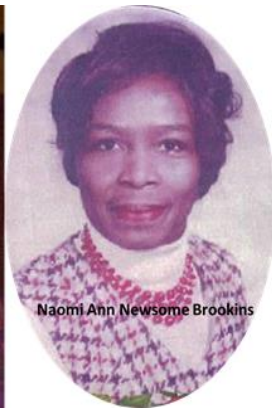

25 U.S. Code § 185. Protection of Indians desiring civilized life

U.S. Code Notes

Whenever any Indian, being a member of any band or tribe with whom the Government has or shall have entered into treaty stipulations, being desirous to adopt the habits of civilized life, has had a portion of the lands belonging to his tribe allotted to him in severalty, in pursuance of such treaty stipulations, the agent and superintendent of such tribe shall take such measures, not inconsistent with law, as may be necessary to protect such Indian in the quiet enjoyment of the lands so allotted to him.

Whenever any Indian, being a member of any band or tribe with whom the Government has or shall have entered into treaty stipulations, being desirous to adopt the habits of civilized life, has had a portion of the lands belonging to his tribe allotted to him in severalty, in pursuance of such treaty stipulations, the agent and superintendent of such tribe shall take such measures, not inconsistent with law, as may be necessary to protect such Indian in the quiet enjoyment of the lands so allotted to him. - - 25 USC § 185 - Protection of Indians Desiring Civilized Life

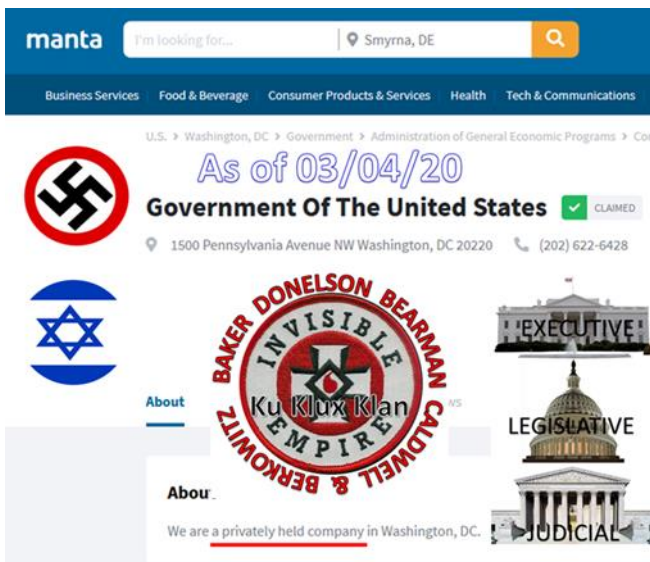

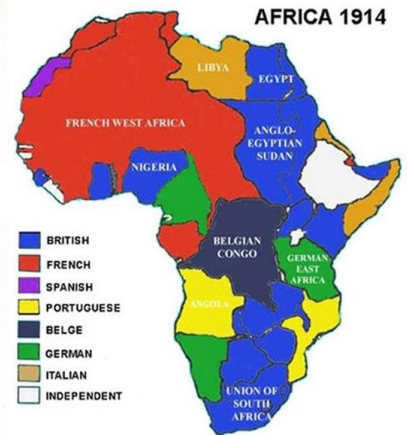

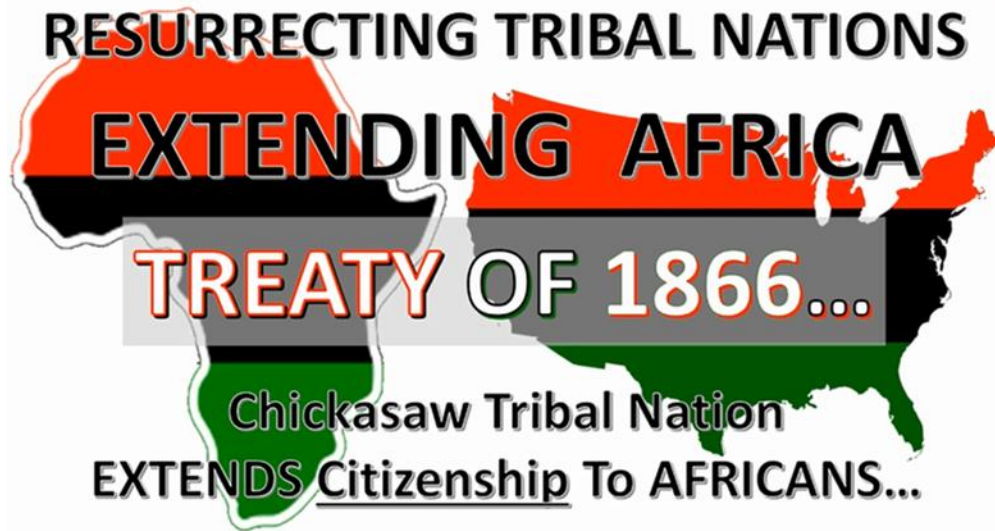

Creating so-called Laws as the **Dawes Act** which “**IMPLIED**” that the Natives were **INFERIOR** to the White Man (when they **were NOT**). 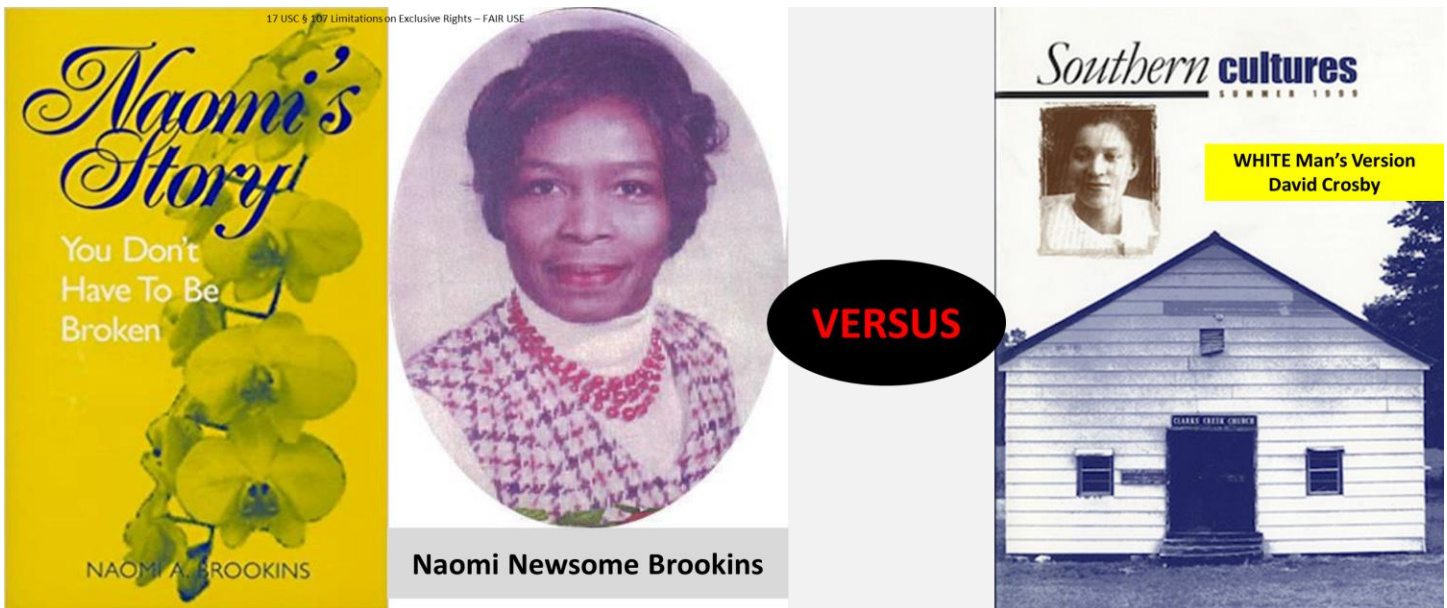

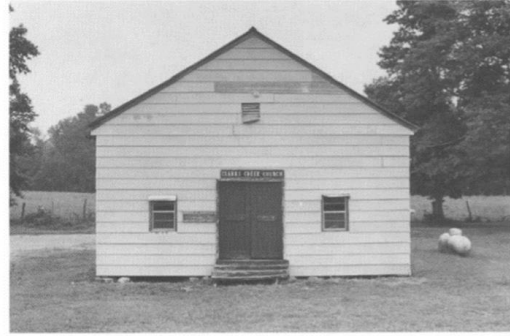

Last Saturday J. A. Roan, white, shot and killed M. Nusom, colored, both of the fifth district. The trouble arose over a board tree belonging to one of the participants. The men had quarreled prior to the killing, and when they met on the road the trouble was renewed. It is said that Nusom advanced on Roan with a heavy stick, when the latter seized a rifle lying in his buggy. Nusom, it is claimed, caught the gun, and a scuffle ensued. Finally Roan got the muzzle turned toward Nusom and fired, the wound producing death soon after.

Roan had a preliminary hearing before Justice Mitchell and was discharged.

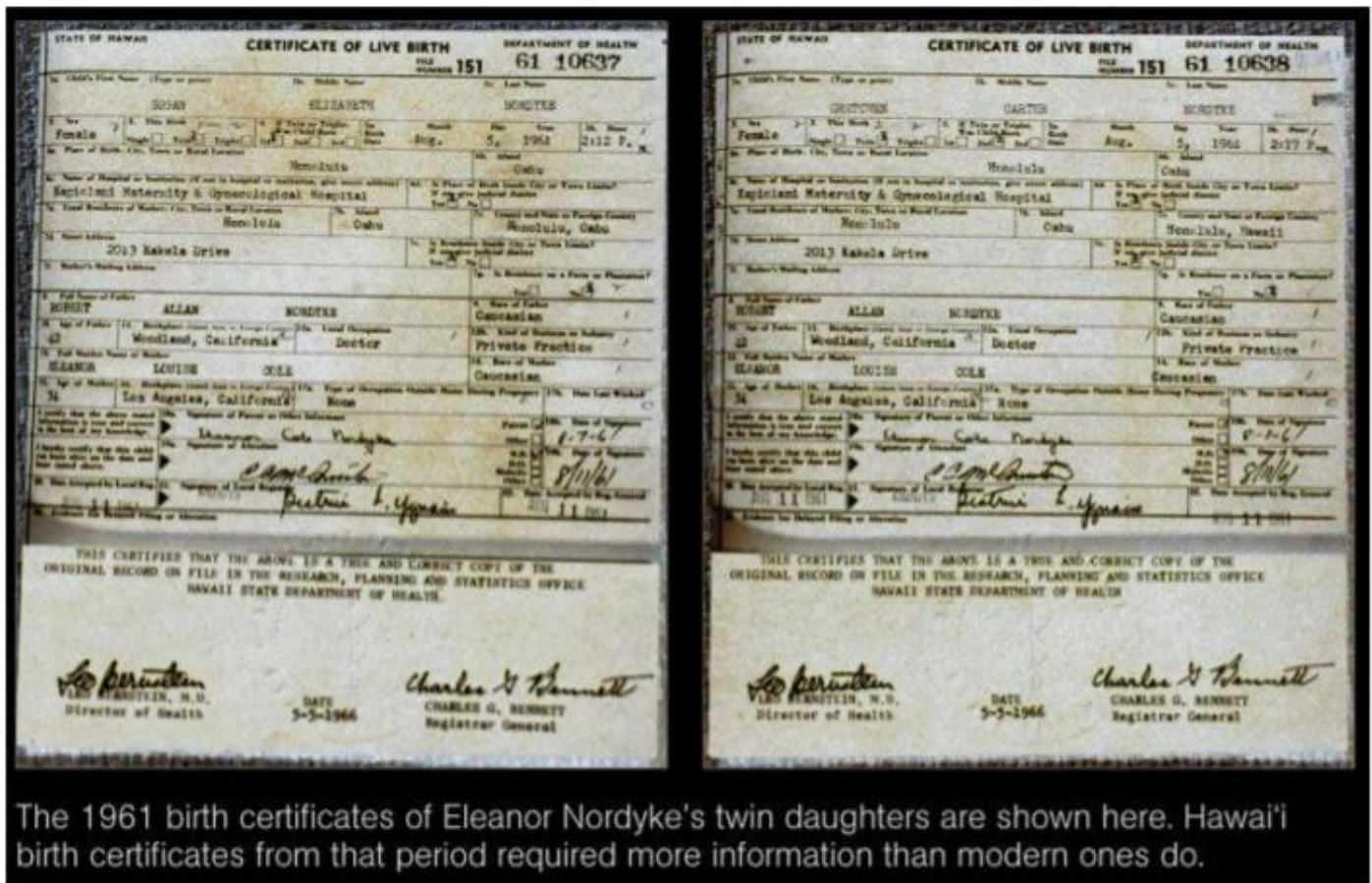

1623. SUBSTANTIVE OFFENSES – KIDNAPPING – 18 U.S.C. § 1201

The act of kidnapping a "foreign official," "internationally protected person (IPP)," or "official guest" is punishable under § 1201(a)(4) without regard to interstate transportation of the victim. The maximum permissible punishment is imprisonment for any term of years or for life and no proof of harm to the victim is required to support any such sentence. A sentence to death or to life imprisonment is authorized by statute "if the death of any person" results from the kidnapping. See JM 9-10.000 for the death penalty policy.

Judgment reversed and suit dismissed for lack of jurisdiction.

- Persons of African descent cannot be, nor were ever intended to be, citizens under the U.S. Const. Plaintiff is without standing to file a suit.
- The Property Clause is only applicable to lands possessed at the time of ratification (1787). As such, Congress cannot ban slavery in the territories. Missouri Compromise is unconstitutional.
- Due Process Clause of the Fifth Amendment prohibits the federal government from freeing slaves brought into federal territories.
