British human rights lawyer elected chief prosecutor of the International Criminal Court

UN Photo/Loey Felipe Karim Asad Ahmad Khan was elected on 12 February 2021 as the new chief prosecutor of the International Criminal Court (ICC).

12 February 2021 | Law and Crime Prevention

Criminal lawyer and human rights expert Karim Khan of the United Kingdom was elected on Friday to be the next Prosecutor of the International Criminal Court (ICC).

He will take office on 16 June, replacing Prosecutor Fatou Bensouda of The Gambia.

The President of the Assembly of States Parties, O-Gon Kwon, applauded Mr. Khan on Twitter, saying "Warm congratulations! Thank you all for your hard work!!"

The 123-member Hague-based court, which began work nearly 20 years ago, is responsible for judgements regarding war crimes, genocide and crimes against humanity.

No stranger to justice

In his 28-year law career, including as a Queen's Counsel in the UK, Mr. Khan has worked as a prosecutor, victim attorney and defense lawyer in national and international criminal tribunals, including the ICC, the International Criminal Tribunal for Rwanda (ICTR), the International Criminal Tribunal for the Former-Yugoslavia (ICTY), the Extraordinary Chambers within the Cambodian Courts (ECCC), the Special Court for Lebanon and the Special Court for Sierra Leone.

The Prosecutor-elect holds law degrees from King's College and the University of London and has studied and taught Islamic law.

Moreover, Mr. Khan is the author of numerous publications in the field of international criminal justice and human rights.

NOT Through The “NEW” World Order International Criminal Courts... i.e. known as Germany’s / Great Britain’s Nazi and Zionist stacked “SONDERGERICHT” Courts - -

A *Sondergericht* was a German "special court". After taking power in 1933, the Nazis quickly moved to remove internal opposition to the Nazi regime in Germany. The legal system became one of many tools for this aim and the Nazis gradually supplanted the normal justice system with political courts with wide-ranging powers. The function of the special courts was to intimidate the German public, . . .

These protections were swept away in the special courts, since they existed outside the ordinary judicial system. There was no possibility of appeal, and verdicts could be executed at once. The court decided the extent of evidence to consider, and "the defense attorneys couldn't question the proof of the charges" . . .

Between 1933 and 1945, 12,000 Germans were executed on the orders of the *Sondergerichte* set up by the Nazi regime. Especially during the first years of their existence they "had a strong deterrent effect" against opposition to the Nazis; the German public was intimidated through "arbitrary psychological terror" . . . -- As of 05/04/20: <https://en.wikipedia.org/wiki/Sondergericht>

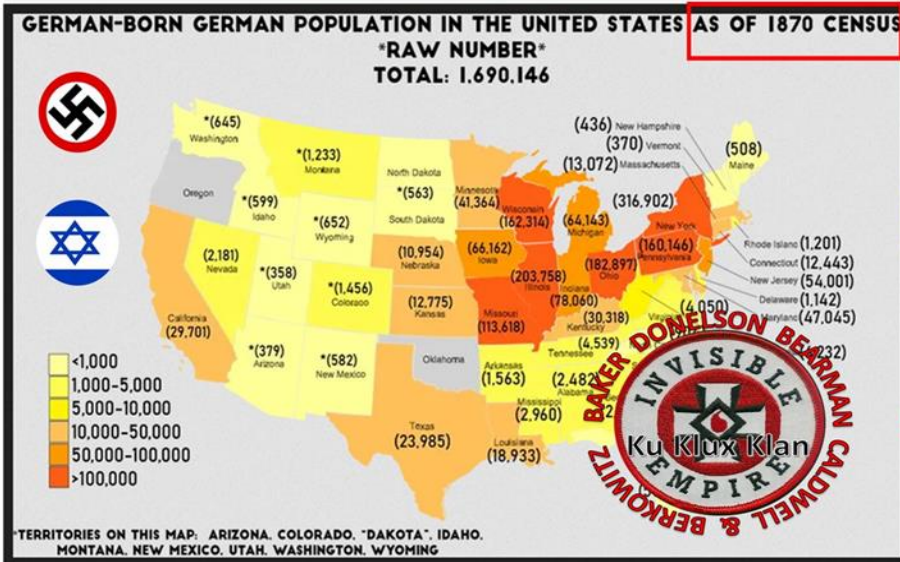
