Addington was also a special assistant for legislative affairs to President Ronald Reagan for one year in 1987, before becoming Reagan's deputy assistant. From 1989 to 1992, Addington served as special assistant to Cheney who was then the Secretary of Defense, before being appointed by President George H. W. Bush and confirmed by the Senate as the Department of Defense's general counsel in 1992.<sup>[17]</sup> In 1993 and 1994, Addington was the Republican staff director of the Senate Intelligence Committee. In 1994 and 1995, he headed a political action committee, the Alliance for American Leadership, set up to support Republican candidates for public office, with a principal focus on being a Presidential exploratory committee for Cheney, as the former Defense Secretary contemplated running for the 1996 Republican Presidential nomination.<sup>[18]</sup>


From 1995 to 2001, he worked in private practice, for law firms Baker, Donelson, Bearman, Caldwell & Berkowitz and Holland & Knight, and the American Trucking Associations.<sup>[19]</sup> He also provided extensive assistance to Dick Cheney when the latter was chief executive officer of Halliburton Corporation and was in charge of vetting potential Presidential running mates for Texas governor George W. Bush, before he was officially his party's nominee for the White House and surprised many political observers by choosing Cheney himself to be his running mate.<sup>[20]</sup>

David Spears Addington (born January 22, 1957) was legal counsel (2001–2005) and chief of staff (2005–2009) to former Vice President Dick Cheney,<sup>[1]</sup> and is now vice president of domestic and economic policy studies at The Heritage Foundation.<sup>[2][3][4][5]</sup>

During 21 years of federal service, Addington worked at the CIA, the Reagan White House, the Department of Defense, four congressional committees, and the Cheney Office of the Vice President.<sup>[6]</sup> He was appointed to replace I. Lewis "Scooter" Libby Jr. as Cheney's chief of staff upon Libby's resignation when Libby was indicted on charges of perjury and obstruction of justice on October 28, 2005.<sup>[7]</sup> Addington was described by U.S. News & World Report as "the most powerful man you've never heard of" in May 2006.<sup>[8]</sup>

In September 2005, Duff was a pallbearer at Rehnquist's funeral,<sup>[1][8]</sup> alongside seven of Rehnquist's former law clerks. Duff authored a tribute to Chief Justice Rehnquist in the November 2005 edition of the Harvard Law Review <sup>[9]</sup> and spoke at the unveiling Ceremony for the William H. From July 2006 through September 15, 2011, Duff served as Director of the Administrative Office of the United States Courts. 

# Q. and A.: The 9/11 Adjuster

In recent weeks, rescue and cleanup workers who sued the city over health damages they attribute to environmental hazards at the former World Trade Center site have been receiving letters explaining how much compensation they would receive under a recent settlement of their claims.

The <u>Garretson Firm Resolution Group</u>, with offices in Cincinnati and Charlotte, N.C., is administering the claims, which involve more than 10,000 plaintiffs. (Ninety-five percent of the plaintiffs must approve the settlement by Sept. 8 for it to take effect.) We talked with Matt Garretson, the company's president and chief executive, about the ins and outs of 9/11 claims administration and calculating the individual settlement amounts. Following are our questions and his responses, edited for clarity and brevity.



**Despotism** is a form of government in which a single entity rules with absolute power. That entity may be an individual, as in an autocracy, or it may be a group,<sup>[1]</sup> as in an oligarchy. The word *despotism* means to "rule in the fashion of a despot" and does not necessarily require a singular "despot", an individual.

**Despot** comes from the Greek *despotes*, which roughly means "master" or "one with power", and it has been used to translate a wide variety of titles and positions. It was used to describe the unlimited power and authority of the Pharaohs of Egypt, employed in the Byzantine court as a title of nobility, used by the rulers of Byzantine vassal states, and adopted as a title of the Byzantine Emperors. Thus, *despot* is found to have different meanings and interpretations at various times in history and cannot be described by a single definition. This is similar to the other Greek titles *basileus* and *autokrator*, which, along with *despot*, have been used at various times to describe everything from a local chieftain to a simple ruler, king or emperor.

Colloquially, *despot* has been applied pejoratively to a person, particularly a head of state or government, who abuses their power and authority to oppress their people, subjects or subordinates. In this sense, it is similar to the pejorative connotations that have likewise arisen with the term *tyrant*. *Dictator* has also developed nearly similar pejorative connotations.<sup>[2]</sup>

Although some explanations of the right of revolution leave open the possibility of its exercise as an individual right, it was clearly understood to be a collective right under English constitutional and political theory.<sup>[8]</sup>

As Pauline Maier has noted in her study *From Resistance to Revolution*, "private individuals were forbidden to take force against their rulers either for malice or because of private injuries....<sup>[9]</sup> Instead, "not just a few individuals, but the 'Body of the People' had to feel concerned" before the right of revolution was justified and with most writers speaking of a " whole people who are the Publick,' or the body of the people acting in their 'public Authority,' indicating a broad consensus involving all ranks of society."<sup>[10]</sup>

### Right versus Duty [edit]

Some philosophers argue that it is not only the right of a people to overthrow an oppressive government but also their *duty* to do so. Howard Evans Kiefer opines, "It seems to me that the *duty* to rebel is much more understandable than that *right* to rebel, because the right to rebellion ruins the order of power, whereas the <u>duty to rebel goes beyond and breaks it</u>."<sup>[11]</sup>

Morton White writes of the American revolutionaries, "The notion that they had a *duty* to rebel is extremely important to stress, for it shows that they thought they were complying with the *commands* of natural law and of nature's God when they threw off absolute despotism."<sup>[12]</sup> The U.S. Declaration of Independence states that "when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their *duty*, to throw off such Government" (emphasis added). Martin Luther King likewise held that it is the duty of the people to resist unjust laws.
