

The Driver's License **is a CONTRACT** that Sovereign Citizens *have been COERCED into purchasing (when NOT needed) and without their knowledge* of being FRAUDULENTLY induced into a Contract/Agreement with the State (as Mississippi) for purposes of being **burdened with TAXATION** and subjected to laws **which INFRINGES** upon SOVEREIGN and PROTECTED rights, etc. Criminal acts which are PROHIBITED under National and International Laws!

12. Driver's Licenses **were created with Criminal Intent to DEFRAUD** and/or SCAM Sovereign Citizens into giving up Constitutional Rights **WITHOUT their knowledge** and, thus, **are NOT** enforceable – i.e. Contracts/Agreements **are NOT binding**, etc.

13. **VEHICLE REGISTRATION** is a *fraudulent process* being used by States (as Mississippi) to induce and/or deceive Sovereign Citizens **to register automobile(s)** – i.e. their mode of traveling - for purposes of inducing them to have some form of Contract/Document (Vehicle Registration) on record **associated with COMMERCE** and/or COMMERCIAL practices. Sovereign Citizens (as Interim Prime Minister Vogel Denise Newsome) **are NOT** required to engage in such criminal activities and have a legal/lawful *duty and obligation* to **EXPOSE** such War Crimes, Crimes Against Humanity, Crimes Against Peace, etc.

14. Under United States Code(s) and/or FEDERAL Laws it **is NOT** a requirement to have a Driver's License, Vehicle Registration or Insurance because one **is NOT** conducting BUSINESS on the Highway(s)/Interstate(s)! For instance, on July 23, 2018, IPMVDN was travelling and minding her own affairs when subjected to the BRUTAL attacks of the Utica, Mississippi Police Department Officials.

15. Under FEDERAL Laws, it is **NOT** illegal/unlawful for one **NOT** to have a Driver's License.

16. Under FEDERAL Laws and INTERNATIONAL Laws, it is **UNLAWFUL** to engage in criminal acts – i.e. fraud, collusion, threats, intimidation, coercion, blackmail, bribes, etc. – to induce one into Contracts/Agreements as Driver's License!

17. States' (as **Mississippi**) – Mississippi being the **MOST CORRUPT** State within the Lands/Territories of the United States of America – PUBLIC OFFICIALS in the Legislature, Law Enforcement, etc. engage in Criminal/Fraudulent practices to induce Sovereign Citizens to obtain Driver's Licenses that are **UNKNOWINGLY** deemed to be Contracts/Agreements that alleges that a person/human is giving **CONSENT** to be **TAXED** (when they **are NOT** knowingly consenting)!

18. 20. 22. Uniform Commercial Code (UCC) under which the State of Mississippi and its Town of Utica are operating and/or may assert the issuance of Uniform Traffic Ticket **is NOT** in line with the Constitution of the United States of America; moreover, INFRINGES upon the SOVEREIGN Rights, Privileges and Immunities of Interim Prime Minister Vogel Denise Newsome!

27. On **September 11, 2018**, a reasonable mind may conclude that (*in keeping with CONSPIRACIES launched against Interim Prime Minister Vogel Denise Newsome*), **Judge Johnnie McDaniel** will proceed to engage in Criminal Activities/WAR CRIMES *in his fulfillment in the CONSPIRACIES leveled against Newsome and the Utica International Embassy, etc.* Judge McDaniel doing so **with knowledge** that the TOWN OF UTICA, Mississippi MUNICIPAL Court **LACK subject matter JURISDICTION** and/or **JURISDICTION** to proceed!

29. Sovereign Citizens **are NOT** advised that matters before the Town of Utica, Mississippi's Municipal Court are being conducted through the use of the STRAWMAN System – i.e. **wherein a FAKE Name** (that appears to look like the name of their VICTIMS for DECEPTIVE and FRAUDULENT purposes) **is used!**

30. On or about July 31, 2018 – approximately EIGHT (8) days later - in keeping with CONSPIRACIES targeting Interim Prime Minister Vogel Denise Newsome and the Utica International Embassy, the TOWN OF UTICA, Mississippi's COURT CLERK (Lisa Morris) proceeded TO ISSUE several Tickets entitled, "STATE OF MISSISSIPPI – UNIFORM TRAFFIC TICKET" upon Newsome with CRIMINAL INTENT and MOTIVES to have a Sovereign Citizen to appear before the Town of Utica, Mississippi's Municipal Court with KNOWLEDGE that **NO FORMAL** Charges have been brought *because NO CRIME has been committed!* Therefore, in keeping with CRIMINAL CONSPIRACIES, etc., several Tickets were issued in efforts to get a Court appearance from IPMVDN through the use of trickery, fraud, collusion, etc.!

32. Judge Johnnie McDaniel, City Prosecutor Melvin J Breeden Jr, Public Defender June Hardwick (ATTORNEYS/LAWYERS **contracted to** the United States of America's **DESPOTISM Empire**) will **NEVER** admit to any of this because they are **SWORN to SECRECY** and/or have entered an AGREEMENT *not to do anything to HURT THEIR PROFESSION* – i.e. expose criminal activities which FINANCE their professions, etc.! Lawyers/Attorneys are in the business of making monies/profit for the United States of America's DESPOTISM Empire!

33. It is advised, that a human/Sovereign Citizens should **NEVER get** Lawyers to defend them **AGAINST** laws when *there are NO victims* because the Lawyers **FIRST OBLIGATION is to the SYSTEM** (Courts as the Town of Utica, Mississippi's Municipal Court – **AGENCY CODE 2508**) **and NOT** to Sovereign Citizens as Interim Prime Minister Vogel Denise Newsome!

34. The Town of Utica Municipal Court is an OFFICE and/or entity of a CORPORATION (i.e. DESPOTISM Government Empire) – assigned **AGENCY CODE 2508** *and EXIST to make a PROFIT/MONIES* for the United States of America's DESPOTISM Empire!

35. ALL crimes are deemed COMMERCIAL!

36. There is NO PROOF that Interim Prime Minister Vogel Denise Newsome has Contract/Agreement with the TOWN OF UTICA, Mississippi and/or STATE of Mississippi to subject her to the JURISDICTION of the Court(s) – i.e. from which she has been BANNED and PROHIBITED from using. Therefore, affording IPMVDN and Citizens of the “NEW” Government of the Utica International Embassy to take the Legal matters before INTERNATIONAL Tribunals!

37. There is record evidence that the TOWN OF UTICA, Mississippi’s Officials having sufficient information that Interim Prime Minister Vogel Denise Newsome [*a person of Native Descent and whose ANCESTORS inhabited/lived within the lands/territories now known as the United States of America BEFORE the WHITE Man came claiming to have discovered*] **has legally/lawfully INVOKED** her SOVEREIGNTY Rights/Privileges/Immunities and **is REVOKING** allege Contracts/Agreements with United States of America/United States’ DESPOTISM Empire pursuant to the TREATY(S) and/or STATUTES and LAWS (National/International) governing such matters!

Moreover, that **“ALL” Parties** to any allege Contracts/Agreements **are MADE AWARE** of the **terms and conditions** to ENSLAVE THEM upon entering alleged Contracts/Agreements! 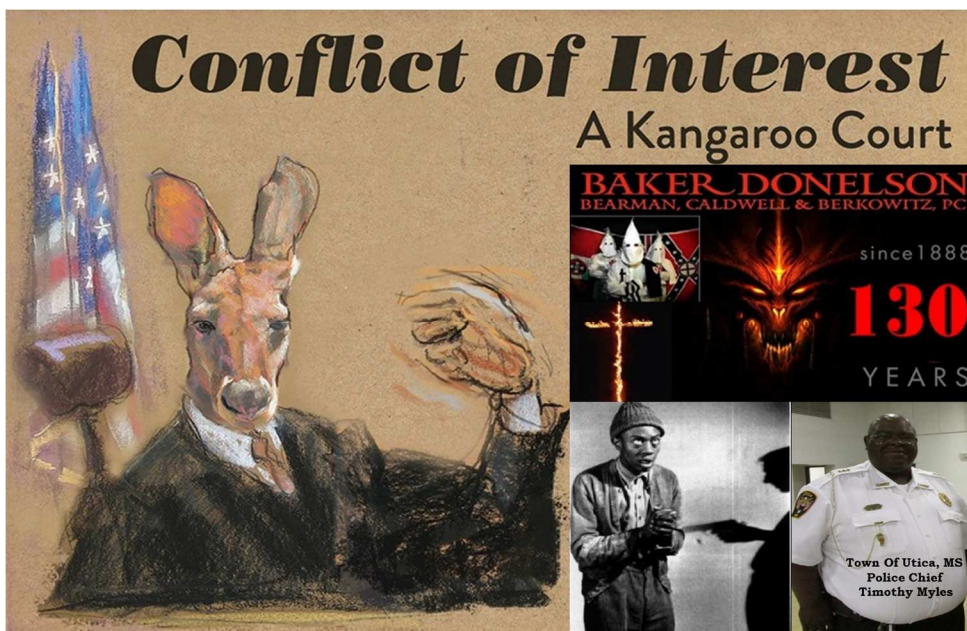
Just as asked, whether one understand the charges, the SAME Magistrate/Judge is to MAKE KNOWN to you the SCAM you are being subjected to; however, does NOT!

The United States has made a surprise revelation that could suggest its campaign to bring down Iran's oil exports to zero is based on "miscalculations" - as Iran had earlier warned.

How do cases come before the Court?

Cases come before the court in one of three ways: (1) The **Court’s Prosecutor** can initiate an investigation into a situation where one or more of the crimes has been committed, based on information from any source, including the victim or the victim’s family, but only if the Court has jurisdiction over the crime and individual. (2) States that have ratified the Rome Statute may ask the Prosecutor to investigate a situation where one or more of the crimes have been committed. (3) The U.N. Security Council can ask the Prosecutor to investigate a situation where one or more of the crimes have been committed, even if the crimes occurred in the territory of a state that has not ratified the Rome Statute or was committed by the national of such a state. In each of these situations, however, it is up to the **Prosecutor, not the states or the Security Council, to decide whether to open an investigation** and, based on that investigation, whether to prosecute, subject to judicial approval.

What is the ICC’s relationship to national courts?

The ICC is a court of last resort. It acts essentially as a safety net when national courts are unable to prosecute, either because the criminal justice system is unequipped or collapsed, or because the perpetrators continue to wield influence over the government. Under the principle of “complementarity,” the ICC prosecutes crimes only when national courts are unable or unwilling to do so, because these crimes are most effectively and fairly prosecuted in the territories where they committed. The ICC will not act if a case is investigated or prosecuted by a national judicial system unless the national proceedings are not genuine, for example if formal proceedings were undertaken solely to shield a person from criminal responsibility. In addition, the ICC can serve as a catalyst and model for reform of domestic laws and procedures: in order for countries to join the Court, they need to bring their laws and procedures into conformity with ICC standards.

 The International Court of Justice (ICJ) is a civil court that hears disputes between countries. The ICC is a **criminal court that prosecutes individuals**. Other international criminal tribunals, namely the *ad hoc* tribunals for Rwanda and the former Yugoslavia, are similar to the ICC but are temporary and have a limited geographical scope. The ICC is a **permanent court, and is global in its reach**.

What is the U.S. position on the Court?
Despite the United States' long history of involvement in international justice, the current U.S. administration has opposed the ICC for fear that the Court will be used politically against U.S. nationals. The Rome Statute, however, incorporates safeguards against politically motivated prosecutions. Moreover, the ICC would only investigate cases involving U.S. nationals if the U.S. failed to investigate and, if appropriate, prosecute the individuals responsible. In 2005, the U.S. government opted to not block a U.N. Security Council vote to refer crimes committed in Darfur to the ICC Prosecutor. This move signaled willingness on the part of the United States to cooperate with the ICC in the investigation.

ARTICLE IV: The State Parties to the present Convention undertake:

Hague Prosecutor Seeks to Pursue Afghan Case That Could Ensnare Americans

By RICK GLADSTONE and MARLISE SIMONS NOV. 3, 2017

The International Criminal Court's prosecutor said Friday that she would request permission to open an Afghanistan investigation, a step that may lead to the court's first indictments of Americans for war crimes.

The prosecutor, Fatou Bensouda, has been collecting information on the war in Afghanistan for years. She has suggested before that she has evidence for a prosecution — not only of allegations of atrocities committed by combatants in Afghanistan, including the Taliban, the Afghan armed forces and the United States military, but of related crimes in other countries where C.I.A. operatives once held and tortured Afghan prisoners.

Ms. Bensouda said she would ask the judges in the court, which is based in The Hague, for authorization to pursue a formal investigation. If they agree, the Afghanistan investigation and any resulting indictments could pose a legal test for the United States — which does not recognize the court's jurisdiction — to cooperate with it, especially if any defendants are American.

"In due course, I will file my request for judicial authorization to open an investigation, submitting that there is a reasonable basis to believe that war crimes and crimes against humanity have been committed in connection with the armed conflict in Afghanistan," Ms. Bensouda said in a statement.

Should the judges grant her request, she said, her office will conduct an independent and impartial investigation into accusations of atrocities "committed by any party to the armed conflict."

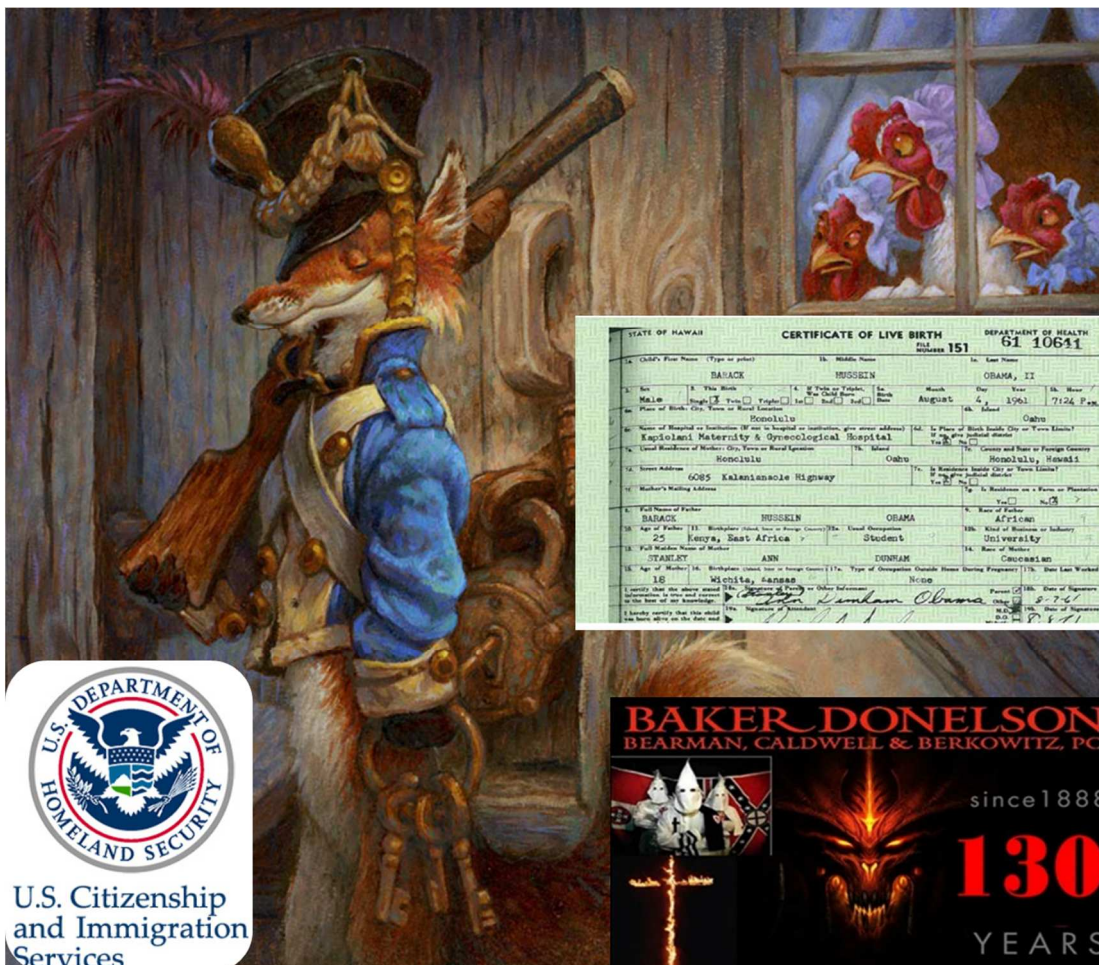



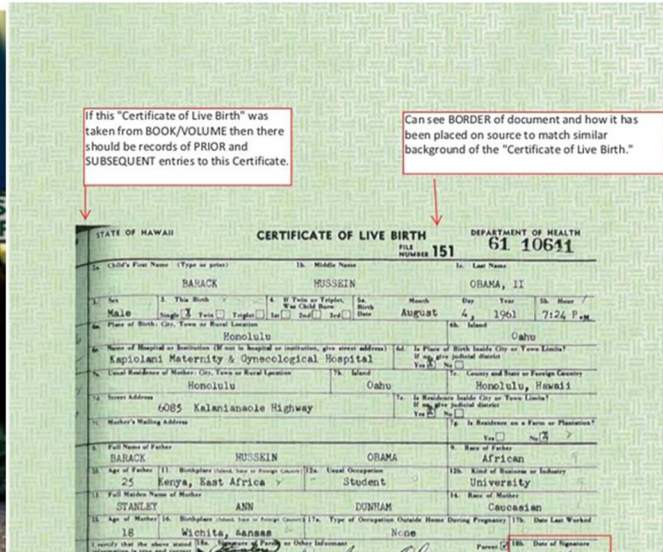

Lance Leggett, a lobbyist at Baker Donelson since 2006, was named Price’s chief of staff earlier this month. In 2016 alone, he lobbied for 10 organizations — all related to health care. Alere Inc, for example, manufactures diagnostic tests and spent nearly \$900,000 lobbying last year. Other clients included hospitals and a medical trade group.

Leggett deregistered as a lobbyist in January, because he was on his way to HHS even before being made chief of staff. In the early days of the administration, Leggett was a member of President Trump’s “beachhead” force, a temporary cast of characters brought in to keep the government running and lay the groundwork for Trump’s agenda. Bin Laden’s father was Mohammed bin Awad bin Laden, a Saudi millionaire from Hadhramaut, Yemen.^[12] His mother, Alia Ghanem, was from a secular middle-class family based in Latakia, Syria.^[13] He was born in Saudi Arabia and studied at university in the country until 1979, when he joined Mujahideen forces in Pakistan fighting against the Soviet Union in Afghanistan. He helped to fund the Mujahideen by funneling arms, money and fighters from the Arab world into Afghanistan, and gained popularity among many Arabs.^[14] In 1988, he formed al-Qaeda.^[15] He was banished from Saudi Arabia in 1992, and shifted his base to Sudan, until U.S. pressure forced him to leave Sudan in 1996. After establishing a new base in Afghanistan, he declared a war against the United States, initiating a series of bombings and related attacks.^[16] Bin Laden was on the American Federal Bureau of Investigation’s (FBI) lists of Ten Most Wanted Fugitives and Most Wanted Terrorists for his involvement in the 1998 U.S. embassy bombings.^{[17][18][19]}

From 2001 to 2011, bin Laden was a major target of the United States, as the FBI offered a \$25 million bounty in their search for him.^[20] On May 2, 2011, bin Laden was shot and killed^[21] inside a private residential compound in Abbottabad, where he lived with a local family from Waziristan, during a covert operation conducted by members of the United States Naval Special Warfare Development Group and Central Intelligence Agency SAD/SOG operators on the orders of U.S. President Barack Obama.^[22]

Obama addresses the nation on the death of Osama bin Laden

Speech Transcript

Good evening. Tonight, I can report to the American people and to the world that the United States has conducted an operation that killed Osama bin Laden, the leader of al Qaeda, and a terrorist who’s responsible for the murder of thousands of innocent men, women, and children.

It was nearly 10 years ago that a bright September day was darkened by the worst attack on the American people in our history. The images of 9/11 are seared into our national memory – hijacked planes cutting through a cloudless September sky; the Twin Towers collapsing to the ground; black smoke billowing up from the Pentagon; the wreckage of Flight 93 in Shanksville, Pennsylvania, where the actions of heroic citizens saved even more heartbreak and destruction.

Then, last August, after years of painstaking work by our intelligence community, I was briefed on a possible lead to bin Laden. It was far from certain, and it took many months to run this thread to ground. I met repeatedly with my national security team as we developed more information about the possibility that we had located bin Laden hiding within a compound deep inside of Pakistan. And finally, last week, I determined that we had enough intelligence to take action, and authorized an operation to get Osama bin Laden and bring him to justice.

Today, at my direction, the United States launched a targeted operation against that compound in Abbottabad, Pakistan. A small team of Americans carried out the operation with extraordinary courage and capability. No Americans were harmed. They took care to avoid civilian casualties. After a firefight, they killed Osama bin Laden and took custody of his body.

(a) KRS Chapters 131, 134, and 135 for the collection, refund, and administration of delinquent taxes, and

WEALTHY Whites and their LAWYERS – i.e. do they have WHITE SUPREMACIST Connections/Affiliations?

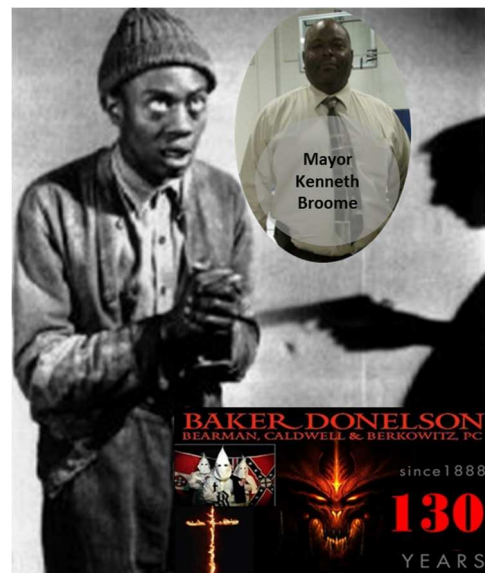

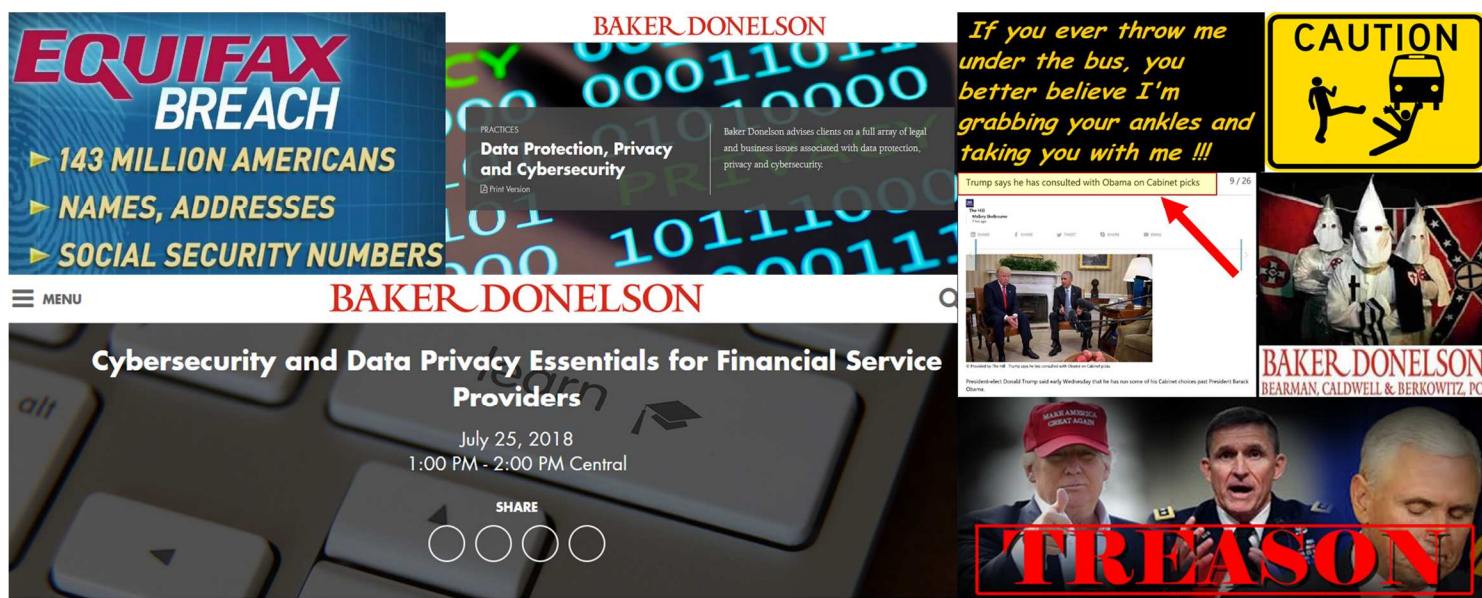


