Recently, the Mississippi Museum of Art unveiled portraits of civil-rights icons Medgar Evers and his wife, Mrs. Myrlie Evers, by the renowned Mississippi artist, Jason Bouldin. Medgar Evers was the first field secretary for the NAACP in Mississippi. His assassination on June 12, 1963, galvanized the civil rights struggle in Mississippi and was a turning point in the national civil rights movement. Mrs. Evers spent 30 years working to convict her husband's killer, served as national chair and president of the NAACP, gave the invocation at President Obama's second inauguration, and is a nationally-recognized civil rights hero.

The Medgar Evers Institute is an Oregon nonprofit corporation organized many years ago by Mrs. Evers to promote racial reconciliation through civic engagement and education. The Firm's pro bono efforts allowed Mrs. Evers to reorganize the Institute to plan and coordinate events to commemorate the 50th anniversary of the assassination of Medgar Evers in June 2013.

With encouragement from Lisa Borden, the Firm's Pro Bono Shareholder, a Baker Donelson team went to work.

- Alan worked with Mrs. Evers to recruit a new, Mississippi-based Board of Directors and develop an action plan for 50th commemorative events held in Washington, D.C., and Jackson in June 2013. He drafted employment and consulting contracts; advised on event management, insurance, fundraising, conflicts of interest, and nonprofit requirements; and drafted a proclamation honoring Medgar Evers, which was unanimously adopted by the Mississippi Legislature.
- Alan also advised the Institute and Mrs. Evers in connection with an agreement with the Mississippi Department of Archives and History for the preservation of personal papers, artifacts and memorabilia of Medgar and Myrlie Evers.

Morris Abram Named As First Jewish Chairman of United Negro College Fund

NEW YORK (Aug. 25)

Morris B. Abram, former president of the American Jewish Committee and Brandeis University, was named yesterday as the first Jewish chairman of the United Negro College Fund which raises money for 36 predominantly black colleges and universities. The schools have a total enrollment of 40,000 students and 2,500 full-time faculty members. As president, Mr. Abram will oversee an effort to raise \$10 million this year, compared with 1969 results of \$6,875,000. The fund tries to cover at least 10 percent of the operating costs of the 36 member colleges.



The close relationship between the Koch brothers, the United Negro College Fund, and UNCF's handsomely compensated CEO shows how a once important creator of African American intellectual and economic growth has fallen for, as the old heads would say, the old okie-doke.

In June, UNCF accepted \$25 million from the Koch brothers.

Anne W. King, an EEOC attorney, wrote the court, "Bass Pro held that the EEOC may bring pattern or practice suits under Section 706 of Title VII of the Civil Rights Act of 1964 and may try such suits in a bifurcated framework."

On Tuesday, counsel for Koch Foods responded that Bass Pro's holding doesn't lend support to the EEOC's argument on appeal in the instant case — that the district court erred by allowing the food distributor in the underlying case to seek U visa information from its employees. U visas enable victims of crimes who meet certain requirements to stay in the U.S.

Instead Scott W. Pedigo, an attorney at Baker Donelson Bearman Caldwell & Berkowitz who is representing Koch Foods, argued, "Efforts to obtain immigration benefits based on [the harassment] allegations are relevant to explain why, when, by whom and under what circumstances the allegations were made."

He added that the visa applications were also important for understanding "the compelling evidence demonstrating the alleged conduct never occurred, and the entire course of events as developed in discovery, all of which directly relate to liability and would be addressed first in any bifurcated trial."






