State v. Carver, 283 N.E.2d 662 - **Each** party to a conspiracy is criminally responsible for all acts done in furtherance of the conspiratorial design.

Bertear v. State - Where conspiracy was established, each conspirator was ***liable for the acts performed by the others in furtherance thereof.***

English v. Matowitz, 72 N.E.2d 898 - ***One need not be present at place of the crime in order to be charged as an aider and abettor or conspirator, but constructive presence is sufficient.***

State v.
