ZIMMERMAN No, this is WHERE I JUST STOPPED TO CALL. . . to call. . .THEN HE WALKED PASS ME and he kept looking at my car . . . STILL LOOKING AROUND AT THE HOUSES and STUFF. . .Then the Dispatcher said, "Where did he go?" "What direction did he go in?" . . . and I said, "I DON'T KNOW". . . cause I lost. . . he cut down here and made a right. . .and this is __ Lane and he made a right in there. . .and they said what direction did he go and I said, "I DON'T KNOW, I CAN'T SEE HIM!"

NOTE: This is a BOLDFACE LIE by George Zimmerman. The 911 Operator **NEVER** asked, "Where did he go?" NOTE: He does PROVIDE a NAME of a STREET in RE-ENACTMENT!

DETECTIVE 2

Okay.

Alright.

ZIMMERMAN

And they said, "CAN YOU GET TO SOMEWHERE WHERE YOU CAN SEE HIM" and I said, "YEAH I CAN" and I BACKED OUT. . .

IMPORTANT TO NOTE: The 911 Operator NEVER asked, "CAN YOU GET TO SOMEWHERE WHERE YOU CAN SEE HIM"

NOTICE: POSTED Street Sign where George Zimmerman alleges he turned right at! Why DIDN'T George Zimmerman come back to this location to get a STREET Name? Because according to the 911 Call, he was out HUNTING a "Faaking Coon!"

ZIMMERMAN And I made this **RIGHT** here...and a LEFT here...and I PARKED right about WHERE THAT SIGN IS IN THE YARD...

DETECTIVE 2 In front of the Ford truck?

... Yes. And I saw him (INAUDIBLE)... Right about there... And I saw him ZIMMERMAN walking back that way and then cut through the back of the houses. He LOOKED BACK and he NOTICED ME and he cuts back through the houses.

I was still on the phone with **NON-Emergency**

Line

Um hum **DETECTIVE 2**

Um. . .. and then he CAME BACK and he started walking up towards the ZIMMERMAN grass and then CAME DOWN and CIRCLED MY CAR. I told the operator that, "THAT HE WAS CIRCLING MY CAR!" I didn't hear if he said anything. . .

IMPORTANT TO NOTE: George Zimmerman **NEVER** told the 911 Operator that Trayvon Martin "WAS CIRCLING MY CAR!" Neither did the Operator EVER say, "WE NEED AN ADDRESS. . . GIVE US DIRECTIONS TO GET TO **YOU...!**"

DETECTIVE 2

Right.

ZIMMERMAN He had his HAND IN HIS WAISTBAND... and I think I told the Operator that. . . and they said, "WHERE ARE YOU?" ULD NOT REMEMBER THE NAME (

Um hum **DETECTIVE 2** Because I DON'T LIVE ON THIS STREET! **ZIMMERMAN DETECTIVE 2** Right. **ZIMMERMAN** Retreat View Circle goes in a circle....

The NEIGHBORHOOD WATCHMAN George Zimmerman is NOT NOTE: STREETS in his neighborhood in which as a familiar with the **NEIGHBORHOOD WATCHMAN he PATROLS and has a WELL-ESTABLISHED** HISTORY of making 911 CRYING-WOLF Calls - i.e. calls which can be checked to determine DIFFICULTY (if any) in reporting addresses to the 911 Operator!

Right... **DETECTIVE 2**

ZIMMERMAN . . . and I said I DON'T KNOW. . . and he goes, "WE NEED AN ADDRESS!" .. . and I said, "I DON'T KNOW AN ADDRESS!" I think I gave them my address. . . and they said, "GIVE US DIRECTIONS TO GET TO YOU" . . . and I said, "IF YOU TELL THE POLICE TO GO STRAIGHT UP TO THE CLUBHOUSE AND MAKE A LEFT, MY TRUCK WILL BE THERE" and again they asked me, "WHERE HE WENT, WHAT DIRECTION DID **HE GO IN**"... and I said, "I DON'T KNOW!" Then I thought, **TO GET OUT AND LOOK FOR A STREET** SIGN."

DETECTIVE 2 Alright.

ZIMMERMAN So I got out of my car and started **WALKING**...



George Zimmerman's CREATION of LIES as he goes along – i.e. QUICKLY thinking and most likely MASTERMINDING with the USE of his CRIMINAL Major classes! NOTICE: <u>HOW</u> Zimmerman is VERY CAREFUL to <u>REITERATE</u> he WALKED – rather than RAN <u>because he was RUNNING AFTER Trayvon</u> Martin on that fateful night! <u>SUPPORTING</u> George Zimmerman was the AGGRESSOR and the person in <u>HOT</u> PURSUIT to KILL/MURDER himself a "F@@KING COON that night!"

And they said, "GIVE ME THE ADDRESS OF THE HOUSE YOU'RE IN FRONT OF". . . and there's NO ADDRESS because these are the BACK of the houses. So I WALKED straight through here and I DIDN'T SEE HIM AT ALL. . .I was WALKING. . . and I was STILL ON THE PHONE with NON-Emergency Line...



NOTICE: George Zimmerman POINTS to the BACK of houses to provide a LIE for not having a Street Address! However, he PARKS in <u>FRONT</u> of houses that would <u>HAVE</u> a <u>STREET</u> ADDRESS – *i.e IF he didn't remember the Street ALL he had to do was DRIVE BACK to where he turned in at to get the name of the street and the FIRST house number when turning in!*



DETECTIVE 2	Okay.
ZIMMERMAN	I got to aboutI got to about here and I had a flashlight.
DETECTIVE 2	Okay
ZIMMERMAN	But my flashlight was dead thoughand I looked around and I DIDN'T see anybodyand I told NON-Emergency Line , "You know where, he's gone!" He's NOT even here!
DETECTIVE 2	Right.
ZIMMERMAN	So, I still thought I could use their address. So I WALKED ALL THE WAY THROUGH and actually walked all the way to the street and I was going to give them this address and they said, "WELL IF HE'S NOT THERE, DO YOU STILL WANT A POLICE OFFICER?" And I said, "YES!" They said, "DO YOU STILL WANT A POLICE OFFICER?" And I said, "YES!" And they said, "ARE YOU FOLLOWING HIM?"Oh, I'm sorry, BACK THERE, they said, "ARE YOU FOLLOWING HIM?" And I said, "Yes" because I was in the area and he said, "WE DON'T NEED YOU TO DO THAT" and I Said, "OKAY!" So that's when I WALKED straight through here to get the address so I could meet the police officer



IMPORTANT TO NOTE: The 911 Operator NEVER said "Well if he's not there, do you still want a Police Officer?" Neither was George Zimmerman WALKING – i.e. from the 911 recording, he was RUNNING according to the wind GUSHING from the rate of speed at which he was moving (he also sounded WINDED/ OUT-OF-BREATH).

and then they said. . .I said, "HE'S NOT HERE". . .they said, "WHERE DO YOU WANT HIM TO COME?" I said, "YOU KNOW WHAT, JUST TELL HIM TO MEET ME AT MY TRUCK. . . NEXT TO THE CLUBHOUSE. . .IF YOU GO STRAIGHT INTO THE CLUBHOUSE and MAKES A LEFT, I HAVE A HONDA . . .I HAVE A SILVER HONDA RIDGELINE, I WAS PARKED RIGHT THERE.

KEEP IN MIND, this CONCOCTED VERSION OF EVENTS is allegedly happening in BETWEEN 4 – 5 MINUTES of a 911 NON-Emergency call – at which Zimmerman states the Operator was still on the phone with him at this point! According to this RE-ENACTMENT, George Zimmerman's truck IS <u>NOT</u> at the Clubhouse – EXPLAINING HOW FAR he RAN in PURSUIT of Trayvon Martin!

> **So I started WALKING back.** When I got to. . .I passed here, I looked. . . He was about there. . .but WALKING TOWARDS ME!



NOTICE: The DISTANCE that George Zimmerman alleges was between him and Trayvon Martin and WHERE the alleged ALTERCATION began – i.e. a DISTANCE AWAY FROM WHERE Trayvon Martin's body was found!



NOTICE WHERE (the LOCATION) Trayvon Martin's remains are!



DETECTIVE 2

So he was coming in this direction here?

ZIMMERMAN

Yes sir. Like I said, I was already passed that so I didn't see exactly where he came from. . .but he was about where you are.



NOTICE: <u>HOW</u> and <u>WHO</u> moved Trayvon Martin's body if the alleged <u>fight took place WHERE</u> George Zimmerman says it did and he is FACE-UP!

ZIMMERMAN	And I said, "I DON'T HAVE A PROBLEM" and I went to GRAB MY CELL PHONE I had left it in a DIFFERENT POCKET and I went I looked down in my pants pocket and he said, "DO YOU HAVE A PROBLEM NOW?" And he was here and he PUNCHED me in the face.


- **DETECTIVE** After you shot him, what did he say?




